### **Please carefully observe the following:**

Any contestant under twenty-one (21) must be accompanied by an adult at all times when not on stage.

There will be a mandatory meeting prior to the contest to determine song selection and performance order.

Contestant order will be determined randomly and drawn at this meeting.

Final number of songs and rounds will be revealed at this meeting.

No custom medleys are permitted outside of standard Elvis medleys such as "Teddy Bear/Don't Be Cruel", "Long Tall Sally/Whole Lotta Shakin' Goin' On", etc. The '68 Gospel Medley counts as 2 songs.

All song selections and versions are subject to review by production staff and the competition band.

Only 1 guitar (one), scarves, a stool (if desired), and water will be allowed on stage with the contestants. No extra lighting or props (teddy bears, backdrops, bodyguards, additional singers, dancers), or anything else will be allowed. Scarves will not be provided.

Contestant lineups and formats, event scheduling, and song selections are subject to change by Windy City ETA Competition prior to and during the event weekend.

Windy City ETA Competition will provide a dressing area, water, and a stage assistant (if desired). Absolutely no alcohol will be permitted on stage. Complimentary snacks and soft drinks will be provided in the dressing area to contestants, staff and guest performers – including food after the competition concludes.

This is for talent and staff only. It will not be provided for any guests or plus-ones with contestants.

### **IMPORTANT: VENUE SECURITY POLICY**

**Backstage dressing room space is very limited and access is only granted to contestants, performers, and show/venue staff. Out of respect for the privacy of our performers: no one will be permitted backstage with contestants...this includes any significant others (wives, girlfriends, partners), family, and friends. They will have to remain outside the dressing area. Security will be present to make sure this guideline is followed. If a contestant does require assistance in getting ready to perform, he may bring one guest backstage temporarily, but only before contestant's turn on stage.**

Please respect fellow contestants, fans, attendees, staff members, judges, and workers.

Rude, indecent, and/or inappropriate behavior will not be tolerated.

Failure to observe will result in disqualification from the contest and a possible ejection from the premises.

Windy City ETA Competition reserves the right to permit or dismiss ETAs in the competition at any time.

The judges who have been selected to score contestants are qualified to do so as Elvis fans who have an above-average familiarity with and knowledge of the music and performances of Elvis, as well as the various aspects of Elvis Tribute Artist production. Their scores are **FINAL**, and tabulated in real time by a third party.
